

HICKORY POINT RECREATIONAL FACILITY FEE SCHEDULE

PAVILION RESERVATIONS

1. Reservations will be accepted no earlier than one year to the date in advance.
2. Reservation fees must be paid in full to reserve the requested date and time.
3. Reservations will not be guaranteed until the application is approved by the Authority.
4. Money orders and checks are to be made payable to the Lake County Water Authority. Credit cards are not accepted.
5. All fees include tax and are subject to change.

CLEANING DEPOSIT

1. All reservations require a cleaning deposit equal to the reservation fee.
2. The cleaning deposit must be paid separately from the other fees.
3. Cleaning deposit must be received in the Water Authority Office at least two (2) weeks prior to the event.
4. Cleaning of the reserved pavilion area must be completed by the end of the reservation time.
5. Upon approval by the park staff, cleaning deposits will be returned at the end of the event.

SPECIAL EVENTS

Activities other than those normally participated in by individuals, such as group gatherings with over 50 participants, special events, fishing tournaments, or regattas. In addition, all gatherings that are open to the general public and/or events that involve a donation or exchange of money as part of guest participation. Special events will be allowed by special permit only, as authorized by the Executive Director.

RESCHEDULING, CANCELLATIONS, and REFUNDS

1. There will be a \$10.00 administration charge to CANCEL OR RESCHEDULE a reservation at any time.
2. After deducting the \$10.00 charge, the remaining reservation fee will be refunded according to the following schedule:

Cancellation more than 30 days prior to event	100% of remainder
Cancellation 7-30 days prior to the event	50% of remainder
Cancellation less than 7 days prior to the event	No Refund

SECURITY GUARDS

The presence of one (1) security guard per 150 guests is required when beer or wine are consumed. Two guards are required if sections of the first and second floor are reserved. The cost (per one guard) is \$ 15.78 per hour (4-hour minimum). Holidays are extra. *Rates are subject to change.*

CERTIFICATE OF INSURANCE – See application for alcohol use and special requests.

FOOD PREPARATION-

There are no facilities available at Hickory Point Recreational Facility for food preservation. Each user must make their own arrangements for food preservation if food is being served. Food may spoil after only a short time without refrigeration, and persons eating the food may become seriously ill. The Lake County Water Authority assumes no liability for the results of food spoilage associated with this reservation.

GRILLS - Portable charcoal grills are provided, at no additional charge, by the Lake County Water Authority.
